## Insurance

Commercial liability insurance provides your business with protection for services rendered or products sold. It also protects your business from claims arising from alleged bodily injury, personal injury, or property damage.

Do not assume your farmers market business activity is covered under your home-owners or farm insurance policy. Talk with your insurance agent about coverage and cost regarding the type(s) of product(s) you are selling.

Many farmers markets require vendors to have commercial liability insurance coverage and to provide the market with a certificate of insurance before a vendor can sell at their market. Check with the market to know what it requires regarding vendor insurance.
